## Regular Board Meeting Minutes

March 5, 2026  
Microsoft Teams

President Lucas Gonyier called the regular meeting to order at 8:30 am. Officers present were President Lucas Gonyier, 1<sup>st</sup> Vice President Adam Coyle, 3<sup>rd</sup> Vice President Todd Nathem, and Secretary Nick Lindberg. Officers absent were 2<sup>nd</sup> Vice President Hollie Bergus, Treasurer Merdith Clark, and Sergeant-at-Arms Michelle Metzger. Quorum reached.

Motion to approve the agenda made by Todd, seconded by Nick; all ayes. Motion to approve the 1-16-26 Regular Meeting Minutes made by Adam, seconded by Todd; all ayes.

No Announcements.

President's Report. Lucas discussed ICC Annual Chapter Reports Part 1 (required) and Part 2 (option). Both were completed and submitted.

Treasurer's Report. Lucas reported an account balance of \$30,200.70. No update from H&R Block. Motion to authorize Lucas to request a quote from a qualified tax attorney and report back to the Board at the next meeting made by Nick, seconded by Todd; all ayes. Motion to approve the Treasurer's Report made by Adam, seconded by Todd; all ayes.

1<sup>st</sup> Vice President's Report. 2026 Fall Conference planning was discussed. The City of Des Moines, lowACE's largest membership, reported that they can likely send members to eastern Iowa this year. lowACE tries to alternate annually between central and eastern Iowa due to membership densities. Board was open to holding a Central Iowa conference. Adam will obtain additional quotes and report back. Potential conference speakers and apps were discussed.

3<sup>rd</sup> Vice President's Report. The required membership report process was discussed. Membership renewals are ahead of schedule compared to last year.

Secretary's Report. Policy documentation was discussed. No 2<sup>nd</sup> Vice President's Report. No Sergeant-at-Arms' Report.

Unfinished Business. Potential spring training speakers were discussed. Board discussed increasing membership fees from \$70 to \$80 for calendar year 2027 as fees have not been raised in several years; tabled until next meeting.

New Business. lowACE becoming an ICC Preferred Provider of Education was discussed. Board asked for clarity on potential training restrictions; Lucas will report back. StarChapter's fees are increasing. Motion to pay \$824.55 and \$382.40 in expenses for hotel and travel for Board Member Michelle Metzger to attend the ICC Leadership Academy in April, pending reimbursement, made by Adam, seconded by Todd; all ayes.

Open Discussion. The president of the Iowa Permit Tech Association reached out to Lucas to consider coordinating conferences to try to get better pricing.

Meeting Planning. The next meeting is tentatively set for March 19th at 11:00 AM at the Pizza Ranch in Grinnell, IA. Motion to adjourn at 9:30 am made by Adam, seconded by Todd; all ayes.
